*The temporary framework regulation was amended three times: on 4 April 2020 (see [Communication from the Commission](#) to provide more scope for research and development relevant to COVID-19, on 8 May 2020 (see [Communication from the Commission](#)) also to enable deployment of resources for recapitalisation, and on 29 June 2020 (see [Press release](#) Commission) to further support micro, small and start-up companies and incentivise private investments.

**This Danish proposal was the first state aid measure proposed by a member state in relation to COVID-19. At the time of approval, the temporary measure of the European Commission for state aid was not in force yet.

***Although, due to its exit from the EU, the United Kingdom is no longer an EU member state, based on the withdrawal agreement between the UK and the EU, EU rules and regulations will remain in full force during the transition period to end 2020. This means that state aid requires the European Commission's approval.
